NOTICE TO MEMBERS

NEW MODE OF OPERATION

AND HHYC RECIPROCAL RIGHTS REINSTATEMENT

3 August 2021

Dear Members

I am pleased to announce that the long awaited reinstatement of Hebe Haven Reciprocal Agreement has been approved and will take effect on **Friday 6 August 2021**.

You are now all familiar with the registration procedure to enter the Club under various operation modes. The Leave Home Safe (LHS) app registration is now well accepted to access the second and third floor. As a result of serving up to six people per table and longer opening hours, we have had an increasing demand to extend our operation mode C to more outlets. Therefore, I am pleased to announce that as of **Monday 9 August**, the Club outlets will operate as follows:

- All outlets will operate under C mode as follows:
- The Four Peaks Restaurant, the Waglan bar and its terrace will remain as they are now;
- The Galley, the Patio and Middle Island will move up to C mode;
- All staff working in or for these outlets would have been vaccinated;
- We can have six people per table; and
- We will be open until midnight.

It also means that all members entering those venues must follow the following rules:

- Each person aged 16 to 64 must use the LHS mobile application.
- Persons aged under 16 with an accompanying adult are exempted from registration.
- Persons aged under 16 without an accompanying adult, and persons aged 65 or above, may opt to complete the new record form available for them.
- No more than 20 people per banquet.
- Operation at 50% capacity.

To facilitate the compulsory LHS registration on Middle Island, each table will have a small version of the QR code. It will be necessary for every member to register on arrival at Middle Island. Staff are empowered to check if this has been done, any breach and / or refusal to comply will result in an immediate request to leave the premises.

May I remind you that under Hong Kong law, such noncompliance to the LHS app registration law, is exposing the club to HK\$ 200,000 and you as an individual to HK\$ 5,000 fine should we fail to comply.

The situation will be reviewed monthly with a progressive increase in capacity in our outlets to operate under D if the demand and the burden of the restriction prove to be acceptable.

In addition, as of Monday 9 August the third floor function rooms will be upgraded to type D private functions.

This means that:

- A table in the function room can host up to 12 People
- Maximum participants to an event has increased from 20 to 100 for ABC.
- Registration with LHS App at the entrance of the club is only necessary if other outlets than the third floor function rooms are intended to be visited.
- 66% of all people attending the event must at have received the first vaccine 14 days prior to the event.
- Vaccinations records have to be declared by the organizer before the function.
- All participants must carry a copy of their vaccine QR code as random checks will be performed.
- The Club reserves the right to ask certain participants to leave the event if the level of vaccinated attendees proves to be insufficient or incorrect on the day.

PRIVATE FUNCTION BOOKING AND ADMINISTRATION PROCEDURE UNDER THE MODE OF OPERATION D

1. On booking an function a Member will have to declare on paper that 66% of his guests will be vaccinated for over than 14 days on the day of the event. A guest list with their guest's vaccination status will need to be produced not less than two days in advance and sent to the Club signed by the organizer.
2. Please be informed that checks may be performed randomly during the event and if the level of vaccination proves unsatisfactory or not matching the declaration, the party will stop or some guests will have to leave to comply with the law.
3. On arrival participants will go straight to the third floor where a check point will be set up with an I-Pad, having the QR code verification from the FEHD and the LHS special QR code to scan for the D mode of operation.
4. For event participants, there will be no more need to register at the Club entrance as long as they go straight to the third floor and do not visit other outlets of the Club.
6. In case of refusal to check in or late arrival we will then approach the organizer informing him or her that random check will be performed and that the party may be stopped or unvaccinated guests must be asked to leave the Club.
