## NOTICE TO MEMBERS THURSDAY 10<sup>TH</sup> FEBRUARY 2022

Dear Members,

### RE: NEWEST COVID 19 REGULATIONS FROM THE GOVERNMENT DATED 8 FEBRUARY.

As the infection rate of the new variant omicron is drastically increasing in Hong Kong more stringent restriction have been put in place starting on 10<sup>th</sup> February until 23<sup>rd</sup> February at best.

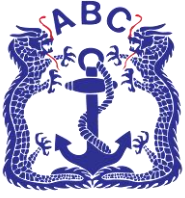
As the Club is already running under the vaccine pass regulation cap 599L, type D operations, not much is added to the already heavy burden put onto you to use the club. Nevertheless, there are some additional closures and procedures to implement.

- All previous rules about mask wearing, sanitizer, temperature taking, use of LHS and vaccination QR code checking, and operating hours remain in place.
- One exemption is made for pre-ordered take away as stated in my previous notice.
- Other exemption for the use of LHS apps have not changed Members over 65 and below 15, Members with disability may enter by filling up the government form at the entrance. This does not exclude unvaccinated Members who still will not have access.
- Only members with valid medical certification, who are ineligible for vaccination due to age; or unsuitable for vaccination due to health reasons will be exempted from the vaccination proof and allowed entry.
- Group gathering in public places under cap 599 G is now reduce from 4 to 2 people and a new provision for private gathering is now restricted to two (2) households (people living under the same roof), I guess this applies to private vessels as well.
- Banqueting and meetings have been cancelled, therefore I am sorry to inform you that all functions booked for the period stated above are now to be re-scheduled at best.
- Table seating, thanks to the Type D mode of operation we can still have 4 people per table instead of 6 and 100% capacity. 1.5 meter distancing between groups needs to be respected.

Please once again assist us to comply with the regulations, use the updated LHS apps to enter the club or have your vaccination paper ready for checking. In addition, for extra precaution against any contamination and avoid closure of the Club, we will increase our club disinfection routine from twice a day to thrice a day including shower, tables, chairs, and doors.

We apologies for any inconvenience caused, but we will continue to strive for your upmost safety and your convenience.
